CONDITIONS OF MEMBERSHIP

The authorization of this agreement along with the payment of the initial fee as well as any required dues, maintenance fees, private or other fees entitle the purchaser/individual identified above, hereinafter referred to as student to become a student in good standing of USA WADORYU (El Toro Judo Club). The student is entitled to use and train at the USA WADORYU facility but is limited to only those programs the student has paid for.

STUDENT HEALTH: The student or legal guardian of (if under 18 years of age) represents that he/she is in physically sound condition and understands that exercise and training in controlled contact sports carry a potential risk of injuries including but not limited to overexertion, muscle strains and pulls, knee and ankle injuries, bruises that are unrelated to the quality of the instruction or equipment used.

ACCIDENTS/INJURY: The student or guardian agree that, all exercises and training at the facility and/or under the guidance of its instructors are undertaken by the student at the sole risk of the student, and that the facility shall not be liable for any claims of injury or damages whatsoever to person or property of the student or of a guest of a student arising out of or connected with the use of the facility. The student and/or guardian agrees to indemnify and to hold the facility and its instructors harmless from all claims by or liability to students, or guests, except for those claims arising out of the facility's knowing failure to correct a gross negligent dangerous situation brought to its attention.

SERVICE OR FACILITY CHANGES: The student acknowledges that USA WADORYU (El Toro Judo Club) guarantees your membership in the organization, but cannot guarantee that the facility will not be altered, moved, or closed.

STUDENT CONDUCT: The student agrees to abide by all rules and regulations of the facility and instructors of, and failure to act in accordance with the rules may result in expulsion from the facility and cancellation of membership. The student agrees that the rules and regulations as well as facilities and instructors are subject to change without notice.

RIGHT TO USE FACILITY: The student agrees that the right to use the facility belongs only to the student named above, and that the membership is non-transferable and non-negotiable.
